City Candidate Elections are held in odd-numbered election years.

School Board Trustee Elections are held on the *3rd Tuesday in May in odd numbered years. Election Official for the School Board is the Clerk of the Board.

*Independent School District of Boise City School Board Trustee Elections are held on the 1st Tuesday in September in even-numbered years.
