

GUIDELINES FOR FILING FOR THE OFFICE OF

SUPREME COURT JUSTICE OR COURT OF APPEALS JUDGE

2014 Primary Election

This information is subject to amendatory change during the 2014 session of the Idaho Legislature. If changes occur, an updated version will be made available.

Filing Period

1st day to file March 3, 2014
last day to file March 14, 2014 Received by 5:00 PM in Secretary of State's office.

A candidate has two options when filing to be placed on the ballot:

1. File the declaration of candidacy and pay the filing fee or
2. File the declaration of candidacy and nominating petitions, containing a certain number of verified signatures.

* All Candidates: Declaration of Candidacy - Form SC-3

1. Print your name exactly as you wish it to appear on the ballot.
2. Signature of candidate must be notarized.

* Option 1: Filing Fee

\$300.00

* Option 2: Petitions - Form SC-4 (may be reproduced)

1. **1,000 signatures** verified by county clerk to be signatures of registered electors prior to being filed with secretary of state. Due to the verification requirement, each signature sheet shall contain signatures of qualified electors from only one (1) county.
2. All petitions must be complete (i.e., the top portion must be filled in and the circulator must have their signature notarized on the bottom portion of the petition prior to being filed with the Secretary of State.)

Campaign Disclosure

1. All candidates must certify a political treasurer. (If you have a current political treasure on file, it is not necessary to file a new Appointment and Certification (C-1 form)).
2. Candidates must file an Appointment and Certification of Political Treasurer (C-1 form) prior to receiving any contributions or making any expenditures. The C-1 form is available from and must be filed with the Secretary of State's Office.

In lieu of the filing fee, this petition must be filed with declaration of candidacy in the office of the Secretary of State during the time prescribed by law prior to the judicial nominating election by candidates for office of Justice of the Supreme Court, Judges of the Court of Appeals, and for the office of District Judge. If the petition is submitted for the office of Justice of the Supreme Court, and Judges of the Court of Appeals, it must have affixed thereto the names of no fewer than one thousand (1,000) qualified electors; if submitted for the office of District Judge, said petition must have affixed thereto the names of no fewer than two hundred (200) qualified electors which reside within the judicial district. The statutory minimum number of signatures must be verified by the county clerks prior to filing with the Secretary of State's office.
