Article 1 - Enter the name of the corporation. Pursuant to Idaho Code § 30-21-302(a), the corporate name must contain the word chartered, professional association, professional corporation, or the abbreviation P.A., P.C., or Chtd.

* **Article 2** - Enter the purpose for which the corporation is organized. You may only use this form if you render services under the practices of: **architecture, chiropractic, dentistry, engineering, landscape architecture, law, medicine, nursing, occupational therapy, optometry, physical therapy, podiatry, professional geology, psychology, certified or licensed public accountancy, social work, surveying and veterinary medicine, and no others.**

Article 3 - Enter the number of shares the corporation will be authorized to issue. There must be at least 1 share authorized in a professional service corporation.

Article 4 - Enter the name and street address of the registered agent of the corporation. A registered agent is the person designated to receive service of process upon litigation. This person must be located in Idaho at a street address.

Article 5 - Enter the name(s) and address(es) of at least 1 incorporator.

Article 6 - Enter the mailing address that you would like future reports mailed to.

The minimum information required by law is that in Articles 1 through 5. Other permissible provisions may be added in the area for optional articles and may be continued on attached sheets if necessary, (e.g. names and addresses of the corporation's directors). You may draft your own articles of incorporation if desired.

The articles of incorporation must be signed by at least 1 incorporator listed in article 5. Please identify the name of the signer by typing his/her name above the signature.

Enclose the appropriate fee (make checks payable to the Secretary of State).

- a. If appropriate fee is \$20.00 (includes a \$20.00 fee for Secretary of State).
- b. If expedited service is requested, add an additional \$40.00 to the filing fee.
- c. If 'same day' service is requested, add \$100.00 to the filing fee.

Pursuant to Idaho Code § 67-910(6), the Secretary of State's office may delete a business entity filing from the database if payment for the filing is not completed.
