

## 2017 Consolidated Election Calendar

School Board Trustee Elections are held on the \*3<sup>rd</sup> Tuesday in May in odd numbered years. Election Official for the School Board is the Clerk of the Board.

\*Independent School District of Boise City School Board Trustee Elections are held on the 1<sup>st</sup> Tuesday in September in even-numbered years.
