Telephone and Office Expenses

As Vice President of Public Policy and Environment for Boise Cascade Corporation, I am provided an office, telephone, assistant and all the other office items necessary to perform the duties of my position. These duties are varied. To attempt to proportionately break down the total of my office and telephone expenses incurred directly as a result of my lobbying duties in Idaho would be speculative.

Early Filing of Annual Report

Effective November 1, 2004, Boise Cascade Corporation is changing its name to OfficeMax, Incorporated. I will not be lobbying in the state of Idaho for OfficeMax thus we are completing the annual filing early.

The portion of Boise Cascade Corporation that has been sold to Madison Dearborn will now be known as Boise Cascade, L.L.C. If it becomes apparent that I will need to lobby for Boise Cascade, L.L.C., I will complete registration for that company.
