<u>HB 21 Sales Tax Exemption Repeal (by Trail):</u> This Legislation would sunset all sales and use tax exemptions by June 30, 2010.	OPPOSE
<u>HB 47 Eminent Domain, Fair Market Value (by ITD):</u> Does not allow project influence to be considered when determining fair market value.	OPPOSE
<u>HB 48 Eminent Domain, Atty Fees and Costs (by ITD):</u> Reduces the ammount of attorney fees and costs that can be recovered from ITD in an eminent domain case.	OPPOSE
<u>HB 52 PUC, New Tax on New Customers (by Stevenson):</u> Would allow the PUC to authorize public utilities to charge an additional tax on new customers.	OPPOSE
<u>HB 54 Eminent Domain, Compensation (by ITD):</u> Reduces the amount of interest paid by ITD on eminent domain cases.	MONITOR
<u>HB 169 Residential Mortgage Practices Act (by Finance):</u> This legislation updates the existing act to comply with some new federal standards.	SUPPORT
<u>HB 188 Real Estate License Law (by IAR):</u> This legislation adds to sections to the duties to a client to clarify that brokerages can represent more than one client looking for similar properties, and that there is no imputed knowledge between agents in an office when there is no reason for them to have such knowledge.	SUPPORT
<u>HB 189 Real Estate - Trust Accounts (by IAR):</u> This legislation clarifs that agents can accept earnest money from their clients and deliver the earnest money to a third party trust account (with written permission from the client).	SUPPORT
<u>HB 190 Representation Agreements, Legal Description (by IAR):</u> This feislation will change the requirement in a representation agreement from a "legally enforceable" description of the property to a general description of the property.	SUPPORT
<u>HB 191 Foreclosure Disclosure Form (by IAR):</u> This legislation would amend the statute with regard to the RE-42 to remove the requirement that it be printed on yellow paper.	OPPOSE
<u>HB 196 Validation of Right Away (by White Peterson Law Firm):</u> This legislation would allow cities the ability to settle disputes over rights of way through the validation process.	SUPPORT
<u>HB 202 Fire Marshall Powers and Duties (by Boyle):</u> This legislation limits the power of the State Fire Marshall to enforcing the IFC on state owned buildings.	SUPPORT
<u>HB 213 Invasive Species Legislation (by Anderson):</u> This legislation would create a permanent funding source to fight invasive species in Idaho.	SUPPORT
<u>HB 218 Fire Sprinklers in Residential Dwellings (by Hart):</u> This legislation makes it clear that Idaho will not adopt portions of the International Codes that require fire sprinklers in residential dwellings.	SUPPORT
<u>HB 220 Relating to the State Building Code Board (by Black):</u> This bill would add a builder to the BCB, and would create a process for the Board to amend adoted codes through a negotiated decisionmaking process.	SUPPORT
