

The Coeur d'Alene Legislative Reception & Dinner was held at the Grove Hotel on February 3, 2011. The entire legislature and their guests were invited, as well as all elected officials and their guests. The total cost for the dinner was \$11,606.31; the cost did not exceed \$100.00 per person.

Entertainment was provided at the event. The cost of the entertainment was \$10,000.00. This total did not exceed \$100 per person.

A toiletry bag (cost \$29.50) or a light weight blanket/throw (cost \$35) were offered as gifts of their choice, to all attendees, including legislators and other public officials at the event, as well as to guests of the legislators and other invited non-legislative and non-public official guests. The items were considered trivial in nature and no record was maintained as to the identity of those who accepted either item listed herein.
