GLOSSARY OF TERMS

- · Fiscal Year: The accounting year used by the state which runs from July 1 of a given year through June 30 of the following year.
- Appropriation: 1. Annual fixed budgets that state officers, departments and institutions may not exceed. 2. That portion of the total state budget allocated by the Legislature to a state agency or program for one fiscal year.
- Classification of funds:
- 1. General: The state's primary source of revenue. In round numbers, one-half of the General Fund comes from the personal income tax, one-third from the sales tax, and one-tenth from the corporate income tax. The remainder comes from taxes on alcohol and tobacco and a variety of other taxes and certain licenses and fees not specifically appropriated to any other fund. General tax revenues are used to finance the operations of state government, such as education and prisons, that do not have their own dedicated source of revenue.
- 2. Dedicated/Other: Represents revenue received from a specified source or sources, and disbursed for a specific function or government as required by law. For example, the Department of Fish & Game receives no General Fund money. Instead, the revenue generated by the sale of fishing and hunting licenses and tags is dedicated exclusively to paying for the department's fish and wildlife management and activities.
- 3. Federal: Identifies moneys from the federal government for specified state administered services.
- Annual Percent Change: The rate at which the 1995 appropriation would have to change on an annual basis to reach the 2005 appropriation.

Total Percent Change: The quantity of the 2005 appropriation minus the 1995 appropriation divided by the 1995 appropriation.

Cost of Living

On the basis of average housing costs, utilities, health care, transportation, groceries, and other services, Idaho's cost of living is the second lowest of the eleven western states. Boise's cost of living is 97.1% of the national average, Idaho Falls' is 99.4%, Pocatello's is 100.2%, and Twin Falls' is 99.0%. The following chart provides a comparison of the relative cost of living in the western states averaged over four consecutive quarters for the participating cities within those states.

Economic Highlights

Idaho: A Healthy and Diversified Economy

- Idaho's personal income increased nearly 22 percent between 1999 & 2003, ranking the state 10th nationally, exceeding the national average (*BEA*, 4/2003).
- Idaho exports increased 6.5% in value during 2003, reversing two years of decline. Top export products include high tech, food & agriculture and wood & building materials. (U.S. Department of Commerce)
- Idaho is number one in the nation in the production of potatoes, trout and winter peas. The state ranks in the top 10 in 22 other products.
- Idaho is 7^{th} in the nation in population growth rate. (*U.S. Census*)

Idaho: A Great Place to Do Business

- Idaho has the 14th lowest overall cost of doing business in U.S., 4th lowest in West (*Economy.com*, 11/2003).
- Idaho's overall tax burden per capita is the 2nd lowest in the West.
- Idaho has the 2nd lowest state and local per capita debt in the nation.
- Between 1997-2004, Idaho ranks fourth in growth of women-owned businesses, first in the nation in employment growth and 3rd in sales. (*Center for Women's Business Research*).
- *Forbes* recently named Idaho the fourth best state in the country for "economic freedom," based on a study it did in conjunction with the Pacific Research Institute.
- "The Gold Guide," published by the National Policy Research Council in Washington, D.C., placed Idaho 13th among all states in the "Best of the Best" ranking. We ranked third in the nation for infrastructure costs and resources (public services and facilities that support business activity), seventh for low crime rate, 14th for economic dynamism and quality of life, and 16th for entrepreneurial climate.

Idaho's Emerging Science & Technology Economy:

- Idaho is number one in the nation for patents issued per capita. Idaho companies such as Micron, Hewlett-Packard and the Idaho National Engineering and Environmental Lab account for a large percentage of the patents issued (*US Patent Trademark Office*, 2001).
