

GLOSSARY OF TERMS

Fiscal Year (FY): The accounting year used by the state, July 1 of a given year through June 30 of the following year.

Appropriation:

- 1. Annual fixed budgets that state officers, departments and institutions may not exceed.
- 2. That portion of the total state budget allocated by the Legislature to a state agency or program for one fiscal year.

Classification of funds:

- 1. **General Fund:** Consists of moneys received by the state from the collection of taxes, and certain licenses and fees not specifically appropriated to any other account, and which are used to finance the general operations of state Government.
- 2. **Dedicated Funds:** These are revenue received from a specified source or courses and spent for a specific function of government as required by law. These funds can also include miscellaneous revenue from the state of goods or services provided to the general public and other political entities.
- 3. Federal: Identifies moneys from the federal government for specified state services.


Land Ownership by County (in acres)
