

GUIDELINES FOR FILING AS AN INDEPENDENT FOR STATEWIDE OFFICE

Governor, Lieutenant Governor, Secretary of State, State Controller,
State Treasurer, Attorney General, Superintendent of Public Instruction

2014 General Election

This information is subject to amendatory change during the 2014 session of the Idaho Legislature. If changes occur, an updated version will be made available.

Filing Period

1st day to file	March 3, 2014	
last day to file	March 14, 2014	Received by 5:00 PM in Secretary of State's office.

Materials Required: Petitions & Declaration

* Declaration of Candidacy – Form SC-1A

1. Print your name exactly as you wish it to appear on the ballot.
2. **You must be registered and affiliated with no political party (i.e. Unaffiliated). (Contact your County Clerk to verify that you are not affiliated with any party).**
3. Signature of candidate must be notarized.

* Petitions - Form SC-2A (may be reproduced)

1. **1,000 signatures** verified by the County Clerk to be signatures of registered electors prior to being filed with the Secretary of State. Due to the verification requirement, each signature sheet shall contain signatures of qualified electors from only one (1) county.
2. All petitions must be complete (i.e., the top portion must be filled in and the circulator must have their signature notarized on the bottom portion of the petition prior to being filed with the Secretary of State.)

Campaign Disclosure

1. All candidates must certify a political treasurer.
2. Candidates must file an Appointment and Certification of Political Treasurer (C-1 form) prior to receiving any contributions or making any expenditures. The C-1 form is available from and must be filed with the Secretary of State's Office.

This petition must be filed with declaration of candidacy in the office of the Secretary of State during the time prescribed by law by independent candidates for United States Senator, Representatives in Congress and all state-wide offices. The statutory minimum number of signatures must be verified by the county clerks prior to filing with the Secretary of State's office. If the petition is submitted for the office of Governor, United States Senator, or any other state-wide office, it must have affixed thereto the names of not fewer than one thousand (1,000) qualified electors. If submitted for the office of United States Representative said petition must have affixed thereto the names of not fewer than five hundred (500) qualified electors who reside within the congressional district.
