UNITED STATES SENATOR OR UNITED STATES REPRESENTATIVE

2016 General Election

This information is subject to amendatory change during the 2016 session of the Idaho Legislature. If changes occur, an updated version will be made available.

Filing Period

1st day to file February 29, 2016

last day to file March 11, 2016 Received by 5:00 PM in Secretary of State's office.

Materials Required: Declaration of Candidacy & Petitions

★ Declaration of Candidacy - Form SC-1A

- 1. Print your name exactly as you wish it to appear on the ballot.
- 2. You must be registered and affiliated with no political party (i.e. unaffiliated). (Contact your County Clerk to verify that you are not affiliated with any party).
- 3. Signature of candidate must be notarized.

* Petitions - Form SC-2A (may be reproduced)

U.S. Senator

- 1. <u>1,000 signatures</u> verified by the County Clerk to be signatures of registered electors prior to being filed with the Secretary of State. Due to the verification requirement, each signature sheet shall contain signatures of qualified electors from one (1) county.
- 2. All petitions must be complete (i.e., the top portion must be filled in and the circulator must have their signature notarized on the bottom portion of the petition prior to being filed with the Secretary of State.)

U.S. Representative

- 1. <u>500 signatures within congressional district</u> verified by the County Clerk to be signatures of registered electors prior to being filed with the Secretary of State. Due to the verification requirement, each signature sheet shall contain signatures of qualified electors from only one (1) county.
- 2. All petitions must be complete (i.e., the top portion must be filled in and the circulator must have their signature notarized on the bottom portion of the petition prior to being filed with the Secretary of State.)

Campaign Disclosure
