

2017 Write-In Candidate Filing Guidelines

May 16, 2017 Election

Districts scheduled to hold Candidate Elections:

Auditorium	Recreational Water and Sewer
Highway	School
Hospital	Water and Sewer
Library	Weather Modification

Filing Deadline:

Declarations and Petitions of Candidacy must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 9th Friday before the Election (March 17, 2017).

Declarations of Intent for Write-In candidates must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (April 1, 2017).

Withdrawal Deadline:

Candidates may submit a Notarized Statement of Withdrawal to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (April 1, 2017).

November 7, 2017 Election

Districts scheduled to hold Candidate Elections:

Cemetery	Fire Protection
Cities	Recreation

Filing Deadline:

Declarations and Petitions of Candidacy must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 9th Friday before the Election (September 8, 2017).

Special Districts: Declarations of Intent for Write-In candidates must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (September 23, 2017).

Cities: Declarations of Intent for Write-In candidates for City elections must be submitted to the City Clerk no later than 5 pm on the 28th day before the Election (October 10, 2017). (**NOTE:** Cities have their own filing forms and petition sheets, which are different than the ones for the special districts.)

Withdrawal Deadline:

Candidates may submit a Notarized Statement of Withdrawal to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (September 23, 2017).

Special Districts: Required Forms for Filing for May or November Elections:

Declaration of Intent – Form EC-2A

1. Print name of the Candidate.
 - a. Enter the Office Title, Election and Date of Election, and Candidate Residence Address.
2. Signature of Candidate must be notarized.
