- 3. In number 3, enter the dollar amount of the claim.
- 4. In bock **4**, for each farm product covered by the lien, you must enter a three (3) digit product code and at least one two (2) digit county code from the tables below. Enter the crop year.
- 5. In block 5, when the obligation has been satisfied, the claimant should sign and date the Release of Lien on the original filing and return it to the Secretary of State.
- 6. Additional producers, claimants, and crops must be entered on Form SL-2 Notice of Claim of Lien in Crops Addendum.
- 7. Include method of payment \$4.00 if typed, \$8.00 if not typed.
