Office of the Idaho Secretary of State - UCC/Liens Database Extract

Following are database table descriptions for the Idaho Secretary of State's UCC/Liens data extract. The purpose of this document is to allow recipients of this information to reconstruct our UCC/Liens database using the attached text files.

The five attached text files* are comprised of raw data extracted from the IDSOS UCC/Liens database and relate to <u>ALL LIENS OF ALL STATUSES</u>. The data in these text files is in **tab-delimited** format and the tables will have to be reconstructed by the recipient of this data. The tables can be constructed according to the layouts described below and then populated with the data from the corresponding text file.

The lookup tables included in this document are to clarify codes found in some of the columns. Since the terminology may differ among agencies, there are no corresponding text files attached for these look up tables. Feel free to contact the Idaho Secretary of State's Office for clarification or more information at (208) 334-5354.

*If you wish to open these text files in an editor first, be sure that the computer you are using has sufficient memory to handle files of more than a million rows.

The changes made to the schema are as follows:

Liens.txt

- 1. Removed the fields for:
 - a. "Expiration Date"
 - b. "Dollar Amount" (this is now being identified in the text of the collateral and on the images)
 - c. "Tax Type"
- 2. Added an "Old File Number" field, as the last field, to cross reference the numbers assigned in the old system (field is empty for filings added in the new system).
- 3. Updated the layout of the "Image" field. The images are now simply referenced by the file number. Both the "File Number' and "Image" fields are being provided, though they should match.

SecParties.txt (formerly "secparty.txt')

- 1. Added an "Amend Number" field after the "Sec Party ID" field. In the new system, secured parties are linked to amendments so that we can track additions, deletions, changes, etc to an amendment.
- 2. Added an "Address Line 3" field after the "Address Line 2" field.
- 3. Combined the previously separate "Zipcode 5" and "Zipcode 4" fields into a single field called "Zipcode".
- 4. Removed the "Foreign Zip" field.
- 5. Added a "Sec Party Action" field to identify whether the SP was ADDED, DELETED or CHANGED

Debtors.txt

- 1. Added an "Amend Number" field after the "Debtor ID" field. In the new system, debtors are linked to amendments so that we can track additions, deletions, changes etc to an amendment.
- 2. Removed the "Name Suffix 2" field.
- 3. Added an "Address Line 3" field after the "Address Line 2" field.
- 4. Combined the previously separate "Zipcode 5" and "Zipcode 4" fields into a single field called "Zipcode".
- 5. Removed the "Foreign Zip" field.

Amends.txt

- 1. Added an "Old File Number" field as the next to last field to cross reference the numbers assigned in the old system (field is empty for filings added in the new system).
- 2. Added an "Old Amend Number" as the last field to cross reference the numbers assigned in the old system (field is empty for filings added in the new system).

AmendActs.txt

1. The values of the "Action Type" field have been updated from a **2 character** representation to a **full description** of the action.

Sample descriptions:

Add EFS Product(s), Delete Collateral, Add Debtor, Delete Debtor, Continuation, Termination, Change Debtor, Change Secured Party, etc.
