

Idaho Secretary of States Office UCC/Liens Database Extract

Following are table descriptions for the Idaho Secretary of State's UCC/Liens data extract. The purpose of this is to allow recipients of this information to somewhat reconstruct our UCC/Liens database using the attached text files.

The five attached text files are comprised of raw data extracted from the IDSOS UCC/Liens database and relate to ALL LIENS OF ALL STATUSES. The data in these text files is in tab-delimited format and the tables will have to be reconstructed by the recipient of this data. The tables can be constructed according to the layouts described below and then populated with the data from the corresponding text file.

The lookup tables included in this document are to clarify codes found in some of the columns. Since the terminology may differ among agencies, there are no corresponding text files attached for these look up tables. * If you wish to open these text files in an editor first be sure that the computer you are using has sufficient memory to handle files of more than a million rows.
